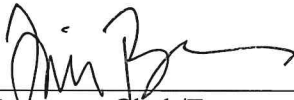
Vote by voice was unanimous and the motion was carried.

Commissioner Hudson made a motion to adjourn the meeting.

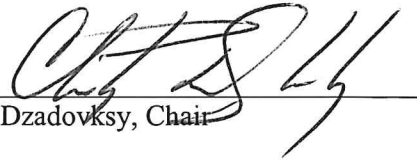
